Think about the Anarchy in the department of Electricity Distribution division II in Mirzapur district where neither poles were installed nor cables were laid down but consumers where made available bills from 4000 to 6000 rupees which is quite obvious from the news report which is published today in the leading Hindi daily Amar Ujala which is not only surprising but also represents Anarchy in the department of Uttar Pradesh Power Corporation Limited and there is resentment against the bills which were arbitrarily issued by the junior engineer and assistant engineer of the Uttar Pradesh Power Corporation Limited. Here this question arises that why government functionaries are not taking seriously against the lawlessness and Anarchy prevailed in the department of electricity in its Mirzapur office which is frequently reported to them. In order to siphon the fund meant to Development Scheme, works are performed on papers and then efforts are made to draw the fund from the public exchequer.

Most revered Sir -Your applicant invites the kind attention of Hon'ble Sir with due respect to the following submissions as follows.

1-It is submitted before the Hon'ble Sir that government has set to do the electrification 100% and in order to achieve its goal it has launched a scheme which is named as Saubhagya scheme and under this scheme connections are provided to the poor villagers but most unfortunate is that under this scheme department of electricity has performed the work on paper only and provides a connection to the villagers without providing them electricity connection and now they have provided the villagers of electricity bill of Rs.4000 rupees to 6000 rupees. Whether such an effort is justified of the erring public functionaries of the Uttar Pradesh Power Corporation Limited?

2-It is submitted before the Hon'ble Sir that Whether it is not tantamount to Daylight robbery which is being done by the staff of the Uttar Pradesh Power Corporation Limited in the Mirzapur district under Jigna feeder? Here this question arises that why the senior rank staffs are mute spectator of this lawlessness and Anarchy in which arbitrary bills are being provided to the innocent and gullible citizenry and complaints are being made before the accountable public functionaries of the department but they are acting like impotent mute spectators and not taking action in the matter which proves that in this large scale irregularity they are also the participants.

3-It is submitted before the Hon'ble Sir that How can it be justified that those drawing a huge salary from the public exchequer are indulged in deep-rooted corruption and not sparing the public fund meant to weaker and downtrodden section?. Whether we have not forgotten our ethical and cultural values originated from our ancestors and we are not making

our ancestors ashamed who were known for their renunciation? Here most logical question is that if this corruption is not supported by the senior rank staffs of the government then why our accountable public functionaries, seated at the chair of senior-most in the administrative hierarchy are mute spectators? Where is the equity for Social Justice in this largest democracy in the world as being claimed by our accountable public functionaries repeatedly?

This is a humble request of your applicant to you Hon'ble Sir that how can it be justified to withhold public services arbitrarily and promote anarchy, lawlessness and chaos in an arbitrary manner by making the mockery of law of land? There is need of the hour to take harsh steps against the wrongdoer in order to win the confidence of citizenry and strengthen the democratic values for healthy and prosperous democracy.
